I received City of Fayetteville, North Carolina, red light camera citation _____. I was not driving a vehicle at the time and location designated in the citation. I did not give permission to the operator of this vehicle to drive my vehicle at the time and location designated in the citation. I will neither pay the civil penalty nor transfer responsibility, this being an option of City of Fayetteville Code of Ordinances Chapter 16, Article VI, Sec. 16-153c-2. Failure to disclose this option on the citation as well as not recognizing this affidavit is extortion--a class F felony in North Carolina (NCGS 14-118.4) and a federal crime (18 US Code § 876).

The second page of your citation under “There are Two Ways to Contest Your Violation” says to go to web site www.violationinfo.com where you can allegedly read Fayetteville ordinance 16-513 and download your Affidavit of Non-Responsibility. But www.violatoninfo.com does not quote 16-513. It quotes NCGS 160A-300-1 where you can only transfer responsibility when your car is stolen or sold or you have to squeal on the driver. The web site does not quote Fayetteville’s 16-513. 16-513 says that you only have to say “I did not give permission to the driver of my car to drive my car at the time and location on the citation” while you do NOT have to squeal on the driver.

The City of Fayetteville with American Traffic Solutions have deliberately committed extortion by limiting your options for the sole purpose of taking your money. A felony: NCGS 14-118.

KEEP A PAPER TRAIL

1. Make a copy of your affidavit before mailing it.
2. Make a copy of your citation.
3. Keep *all* the pages of the citation.
4. Mail the affidavit with the copy of your citation using “Delivery Confirmation”. You need to have the date the US Post Office mailed the letter.
5. Make sure you mail your affidavit to Fayetteville within 28 days of your violation.
6. Go to <http://www.violation.com> within 60 days of your violation. Download the full-resolution photos and the video. The written information at the top of the photos is extremely important.
7. If Fayetteville sends you a Penalty letter, ignore it but keep the letter.
8. If Fayetteville collection agency sends you a letter, keep it.
9. Scan in all your paperwork and e-mail it to canute@redlightrobber.com. Email the downloaded photos and video too. In your scans, we must be able to read the small print inside the photos on your citation.
